2. Japan has been free from Foot-and-mouth disease (FMD), Rinderpest, contagious bovine pleuropneumonia (CBP) and African swine fever (ASF).
3. Vaccination against FMD, Rinderpest, CBP and ASF is completely restricted by laws of Japan.

(Requirements for the Designated Establishment)

4. The cloven-hoofed animals which have been slaughtered and processed in the Designated Establishment have been born and raised in Japan.
5. The Designated Establishment has kept the records concerning the species of the animal slaughtered, the sites of the animals raised, the date and the quantity of the products processed for at least two years.

(Requirements for inspection)

6. The meat or meat products hereon described were derived from animals that received both ante-and post-mortem veterinary inspection at the time of slaughter in the Designated Establishment; the meat is sound, healthful, wholesome and fit for human consumption; and necessary precautions were taken in preparing and packing of the meat.
7. The product has not been contaminated with any infective organisms or toxic substances before shipping and during transportation.
