

XVI Foreign Trade of Agricultural, Forestry and Fishery Products

Explanation

This part contains data on Japanese exports and imports of agricultural, forestry and fishery products, those of materials for agricultural production, and data on Japanese exports and imports by region and country of destination or origin.

1 Value of exports and imports by region and country by special classification of commodity

- (1) Statistics region based on the "Summary Report on Trade of Japan" compiled by the Japan Tariff Association and prepared by rearranging the data by commodities and by region and country.

Classification of countries by continents and by regions is as follows:

- g Middle East : Iran, Iraq, Bahrain, Saudi Arabia, Kuwait, Qatar, Oman, Israel, Jordan, Syria, Lebanon, The United Arab Emirates, The Republic of Yemen and The West Bank and Gaza Strip
- h Africa : Morocco, Ceuta and Melilla (Sp.), Algeria, Tunisia, Libya, Egypt, Sudan, West Sahara, Mauritania, Senegal, The Gambia, R Guinea B, Guinea, Sierra Leone, Liberia, Coted Ivire, Ghana, Togo,

i EU (European Union) : Sweden, Denmark, United Kingdom, Ireland, Netherlands, Belgium, Luxembourg, France, Germany, Portugal, Spain, Italy, Finland, Austria, Greece, Romania, Bulgaria, Malta, Cyprus, Slovenia, Poland, Hungary, Estonia, Latvia, Lithuania, Czech, Slovakia (as of Dec.31, 2012)

(2) Since 1988, this classification is based upon the Harmonized Commodity Description and Coding System (HS).

(3) In principle, export prices are the FOB prices and import prices are the CIF prices.

2 Japan trade of agricultural, forestry and fishery products

Figures are prepared based on the "Trade Statistics of Japan" compiled by the Customs Bureau of the Ministry of Finance, by re-tabulating data according to the definitions of the International Affairs Department of MAFF.

3 Trade of materials for agricultural production

Statistics are on agricultural machinery, fertilizers, agricultural chemicals and feeds, data for which are extracted from the "Monthly Report on Japan Exports and Imports" compiled by the Japan Tariff Association.
