Subject: Renewal of Recognition of Japan's Food Safety Control System

Dear Excellency,

Indonesian Agricultural Quarantine Agency (IAQA) presents its compliments to the Embassy of Japan in Jakarta and has the honor to inform the Government of Japan that the Minister of Agriculture has stipulated the Decree No. 262/KPTS/KR.050/M/4/2021 regarding the Recognition of Japan's Food Safety Control System on 22 April 2021 (attached). The Decree is valid since 7 May 2021 for three years. The scope of recognition is apple.

The food safety requirements for the exportation of apple to Indonesia are:

- 1. Every consignment must be accompanied by Prior Notice issued by the Japan's exporter (or its representative) in Japan;
- 2. Prior Notice must be issued before the FFPO arrived in Indonesia.

We would like to remind you that the Government of Japan must annually report the complete result of national food safety monitoring to the Director General of IAQA. In addition, any changes on Japan's food safety regulation or food safety outbreaks should be informed to IAQA.

We highly appreciate Japan's commitment and continuous effort to ensure the safety of FFPO exported to Indonesia.

Thank you for your kind attention and looking forward to continuing our valuable cooperation. IAQA avails itself of this opportunity to renew to the Embassy of Japan, the assurance of its highest consideration.

DECREE OF THE MINISTER OF AGRICULTURE REPUBLIC OF INDONESIA NUMBER 262 / KPTS / KR.050 / M / 4/2021

REGARDING THE RECOGNITION OF JAPAN'S SAFETY CONTROL SYSTEM OF FRESH FOODS OF PLANT ORIGIN

BY THE GRACE OF GOD ALMIGHTY

MINISTER OF AGRICULTURE OF THE REPUBLIC OF INDONESIA,

Considering:

- 1. that with the Decree of the Minister of Agriculture Number 322 / Kpts / KR.050 / 1/2018, the Recognition of the Safety Control System for Fresh Origins of Japan has been established;
- 2. that the Japanese has filed an appeal for the recognition of the safety control system for the fresh food of plants origin;
- 3. that based on the results of application review as referred to in letter b, the safety control system of fresh foods of plant origin, Japan has fulfill the requirements to be given the recognition of the safety control system of fresh food of plants origin;
- 4. that based on the considerations as intended in letters a, b and c, as well as in accordance with the provisions of Article 21 Regulation of the Minister of Agriculture Number 55 / PERMENTAN /KR.040/11/2016 regarding Food Safety Control to the Import of Fresh Food of Plants Origin, it is necessary to stipulate a Decree of the Minister of Agriculture regarding the Recognition of the Safety Control System of Fresh Food of Plants Origin from Japan.

TO DECIDE:

To enact: THE DECREE OF THE MINISTER OF AGRICULTURE REGARDING THE RECOGNITION OF SAFETY CONTROL SYSTEM OF FRESH FOOD OF PLANTS ORIGIN OF JAPAN.

- FIRST: Give recognition to the food safety control system of fresh foods of plants origin of Japan.
- SECOND: The type of fresh food from plants which is given recognition as meant in the FIRST dictum is Apple.
- THIRD: Recognition as meant in the FIRST dictum is frozen or revoked in the event of a discrepancy as regulated in the provisions of the Legislation in the field of safety control of fresh food of plants origin.
- FOURTH: The Japanese Food Safety Competent Authority (OKKP) is obliged to report the results of the national food safety control program annually during the recognition period.
- FIFTH: The recognition as referred to in the FIRST dictum is valid for a period of 3 (three) years since this Ministerial Decree comes into effect.
- SIXTH: When this Ministerial Decree comes into effect, the Decree of the Minister
 of Agriculture Number 322 / Kpts / KR.050 / 1/2018 regarding Recognition of the
 Safety Control System of Fresh Food of Plants Origin of Japan is revoked and
 declared invalid.
- SEVENTH: This Ministerial Decree shall come into force on 7 May 2021.
