

# STOP the invasion of Animal diseases from overseas

Countries and Regions with outbreaks



Strict control at entry points by Animal Quarantine Service, MAFF  
- Quarantine for export/ import of Animals and Animal products

**DO NOT bring into Japan any livestock products from overseas.**

(Almost all carry-on livestock products such as raw meat, hams and sausages **CAN NOT** be imported into Japan. DO NOT have them sent through the mail or by international delivery service from overseas either.)

**STOP**



**DO NOT bring into Japan any items that have been in contact with livestock or manure overseas.**

(Please present any items that have been in contact with Animals or Manure to the **Animal Quarantine Counter** in the baggage claim area before Customs.)

National Border

**DO NOT bring clothes and shoes that have been used outside Japan in the last 4 months into any Biosecurity Control Areas.**

(If entering a Biosecurity Area with these objects is unavoidable please take all necessary precautions such as **washing and disinfecting the objects**, before entering the area.)

**DO NOT visit livestock facilities in Japan within one week of your entry.**

(If entering a Biosecurity Control area is unavoidable, please take all necessary measures, such as **showering and hair-washing, changing clothes and shoes** before entering the area.)

- Compliance with biosecurity standards

# Please distribute the following notice to your foreign trainees (students).

**DO NOT bring any livestock products !**



- Almost all carry-on livestock products such as raw meat, hams and sausages **CAN NOT** be imported into Japan.
- **DO NOT** have them send through the mail or by international delivery service from overseas either.
- If you receive any livestock products without the correct import procedure, please contact the nearest **Animal Quarantine Service\***.

**DO NOT bring any agricultural material !**



- **DO NOT** bring agricultural material including overalls(jumpsuits) and boots used overseas to Japan.
- If you do have any agricultural material, please present them at the **Animal Quarantine Counter** in the baggage claim area before Customs. *(The Animal Quarantine Officer can then take all necessary measures including washing and disinfecting.)*

**DO NOT have contact with livestock overseas !**



- **Avoid** having contact with livestock overseas for at least one week before coming to Japan.
- **DO NOT** visit livestock facilities in Japan within one week of your entry.

*(If entering a Biosecurity Control area is unavoidable, please take all necessary measures, such as showering and hair-washing, changing clothes and shoes before entering the area)*
