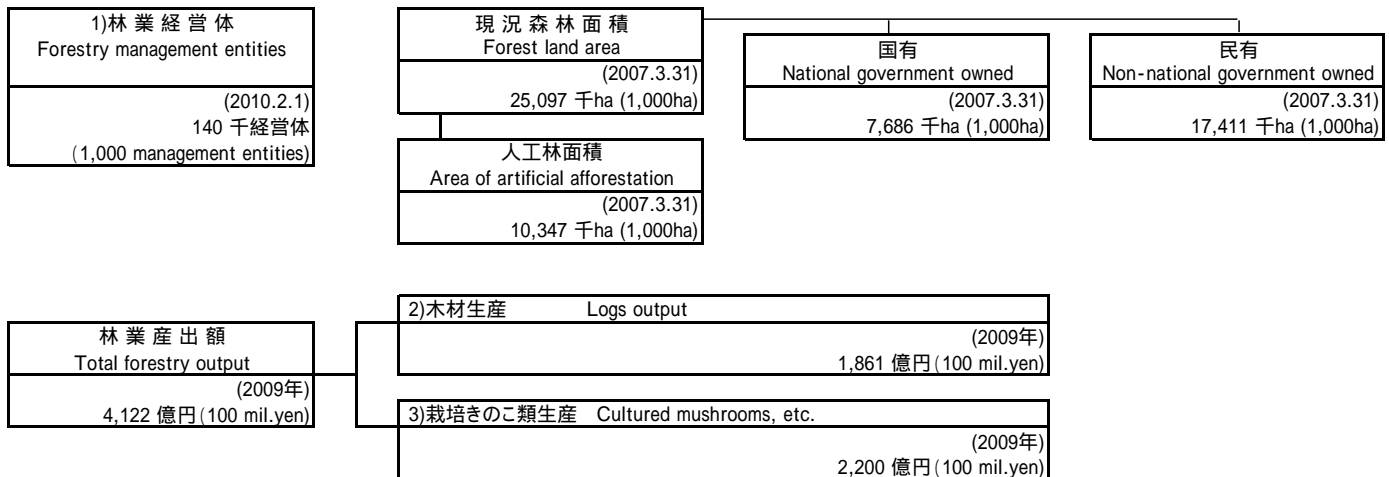


(2) 林業生産の概要 Summary of Forestry Production



農林水産省統計部「2010年世界農林業センサス」の結果資料(確定値)及び『生産林業所得統計報告書』並びに林野庁『森林・林業統計要覧』による。
注:1)は、権原に基づいて育林又は伐採(立木竹のみを譲り受けてする伐採を除く。)を行うことができる山林の面積が3ヘクタール以上の規模の林業、委託を受けて行う育林もしくは素材生産又は立木を購入して行う素材生産の事業、のいずれかに該当する事業を行う者をいう。

2)は、樹種別産出額を合計して求めた。木材産出額(樹種別) = 生産量 × 価格

3)は、種類別産出額を合計して求めた。栽培きのこ類産出額(種類別) = 栽培きのこ類生産量 × 価格

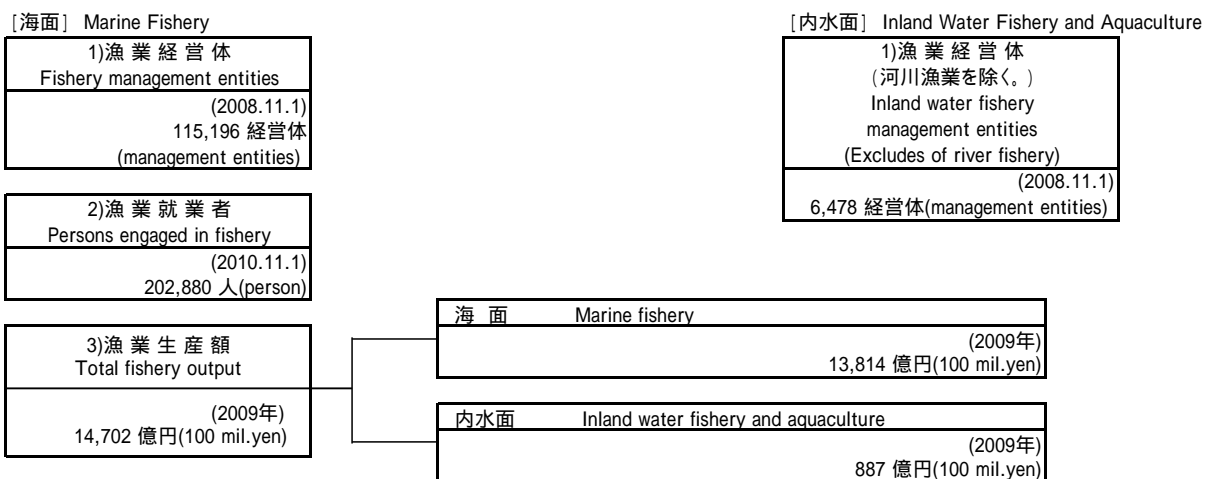

Notes: 1) Forestry management entities refer to those engaged in businesses that fall under either : Forestry with sizes of 3 hectares and over of forest area where the owner can grow or cut trees (excluding cutting of procured standing trees and bamboos only), business for commissioned silviculture or logs production, or business for log production by buying standing trees.

2) They are total of by type of output. "Logs output" = Logs production × Logs prices

3) They are total of by type of output. "Cultured mushrooms, etc." = "Shiitake" and other mushroom production × prices

(3) 漁業生産の概要 Summary of Fishery Production



農林水産省統計部「2008年漁業センサス」、『漁業就業動向調査報告書』及び『漁業・養殖業生産統計年報(併載:漁業生産額)』による。
注:1)は、過去1年間に利潤又は生活の資を得るために生産物(養殖業の収穫物を含む。)を販売することを目的として営んだ世帯又は事業所をいう。ただし、海面漁業については過去1年間における海上作業従事日数が30日未満の個人経営体は除く。

2)は、満15歳以上で過去1年間に漁業の海上作業に年間30日以上従事した者をいう。

3)は、漁業・養殖業(近海小型捕鯨を含む。)の魚種別生産量に魚種別産地市場価格を乗じて推定した金額である。

Notes: 1) It is households and establishments that caught or cultivated fishes for the purpose of gaining profit or income by selling them, during the year preceding the date of the survey. However regarding the marine fishery, individual enterprises, which engaged in marine fishery works for under 30 days during a year preceding the date of the survey, are excluded from "Fishery enterprises".

2) It is members of fishery households 15 years old or more, engaged in marine fishery works for more than 30 days during a year preceding the of date the survey.

3) It is result of the estimation methods, Total Fishery Value = Quantities of marine fishery production (including off shore small whaling) × Wholesale prices in producing areas
