<b>5. Title, language and number of pages of the notified document:</b> Industry Notice: Proposed changes to AQIS import requirements for wood packaging under <i>ISPM 15: Guidelines for Regulating Wood Packing Material in International Trade</i> . (available in English, 2 pages).
<b>6. Description of content:</b> Australia proposes to adopt the <i>International Standard for Phytosanitary Measures No. 15: Guidelines for Regulating Wood Packing Material in International Trade</i> (ISPM 15). Australia has regulated standards for wood packaging material and dunnage for many years, and, intends to incorporate the provisions of ISPM 15 into Australia's existing measures for wood packaging material and dunnage. In addition to the ISPM 15 measures, Australia will maintain the following existing requirements: <ul style="list-style-type: none"><li>• freedom from bark; and</li><li>• methyl bromide fumigation at 48 grams per cubic metre for 24 hours (not 16 hours) and the timber at time of treatment being no greater than 200mm in diameter in the smallest plane.</li></ul> Australia will re-evaluate its required treatment period of 24 hours after the findings of an international review of the methyl bromide treatment specified under the ISPM 15 standard have been released.

This will ensure continued market access to Australia for countries not in a position to implement ISPM 15.</p>
