6.	<b>Description of content:</b> Proposed changes to the Import Health Standard (IHS) include: (1) <b>Inspection of all non-compliant wood packaging:</b> The most significant change to the IHS is the inclusion of the option to inspect all non-ISPM 15 compliant or untreated Wood Packaging Material (WPM). (2) <b>Tolerance level for debarked wood:</b> The proposed amendment to the IHS aligns with the ISPM No.15 (2009) which states that any number of small and clearly distinct pieces of bark may remain on imported wood packaging material if they are less than 3 cm in width, or if wider than 3 cm, the total surface area of each bark piece is less than 50 cm <sup>2</sup> . (3) <b>Changes to Other Treatments Approved by New Zealand:</b> The approved phosphine fumigation rate has been increased to 3.0 g/m <sup>3</sup> for at least 120 hours (5 days) at a temperature of 15OC or above. The increases in the fumigation rate and time of application are based upon results from the latest research on phosphine fumigation efficacy of quarantine timber pests conducted in New Zealand.
