

# Examples of Inspection Certificates attached to an animal product

Meat products bearing an inspection certificate intended for entry into Japan are sold at some duty-free shops and other outlets in the U.S. (including Hawaii, Guam and Saipan), Canada, Australia, and New Zealand, and only those with the certificate, can be brought into Japan.

However, products without Inspection Certificate cannot be brought into Japan despite having been promoted as importable by a sales assistant at a duty-free shop. ※

Please note that a product sold in a country with an Inspection Certificate originating in a different country or the product whose packaging has been opened before the inspection at the Animal Quarantine Service, cannot be brought into Japan.

## ※ ATTENTION!!

As from Dec.2003

Even with the Inspection Certificate, it is impossible to import meat products derived from cattle such as beef jerky from the US and Canada, due to outbreaks of Bovine Spongiform Encephalopathy in those countries.



**USA**

(Only for pork and poultry products)

The meat contained herein is for personal use only and not for sale. It is derived from animals that received antemortem and postmortem inspection and were found sound and healthy and has been inspected and as provided by law and regulations of USDA.



The meat contained herein is for personal use only and not for sale. It was legally imported into the United States directly from (Australia or New Zealand) and was packed in a USDA approved plant under the supervision and control of the USDA.



The meat contained herein is for personal use only and not for sale. It was legally imported into the United States directly from (New Zealand) and passed import inspection by the USDA.
