I, the undersigned official veterinarian, certify that;

1. Japan is recognized by the World Organisation for Animal Health (OIE) as having negligible BSE risk according to Resolution No. 20 of the 81th General Session in May 2013, satisfying the conditions in Chapter 11.5 of the Terrestrial Animal Health Code of the OIE (OIE Code).
2. The meat was derived from animals which were born seven years after the ban on the feeding of ruminant protein (excluding components permitted by the OIE Code) and mammalian meat/bone meal to ruminants has been effectively enforced since 1 November 2001.
3. The meat was derived from animals which have not received feed of animal origin, manufactured from internal organs and tissues from ruminant animals (excluding components permitted by the OIE Code).
