

Animal Quarantine Service accused twoJapanese of illegally exporting and importing prohibited articles against Act on Domestic Animal Infectious Diseases Control on 29 January 2019. Osaka Prefectural Policy Headquarters arrested them on 9 March 2019.

Metropolitan Police Deaprtment arrested the Vietnamese on 21 July 2019.
Import	Livestock derived products (hand luggage)	Philippines	Act on Domestic Animal Infectious Diseases Control, Article 36(1),63(2) Enforcement Regulations of the Domestic Animal Infectious Diseases Control Law, Article 43	① TwoJapanese illegally carried 91.9 kg of sausage from Philippines into Fukuoka International Airport in Japan, which is prohibited by the law, on 17 May 2019. ② TheJapanese ilegally carried 20.2 kg of products derived from pig and poultry meat from Philippines into Chubu International Airport in Japan, which is prohibited by the law, on 31 May 2019.		Animal Quarantine Service, Moji Branch and Chubu Airport Branch accused the Japanese of illegally importing prohibited articles against Act on Domestic Animal Infectious Diseases Control on 29 May 2019 and 15 August 2019, irresprctively. Fukuoka Prefectural Police Headquarters arrested them on 6 August 2019, and re-arrested them on 27 August 2019

Animal Quarantine Service, Haneda Branch notify Metropolitay Police Department of it on 3 September 2019, and then the Police arrested the Thai on the same day.
Import	Livestock derived products (hand luggage)	Vietnam	Act on Domestic Animal Infectious Diseases Control, Article 36(1),63(2) Enforcement Regulations of the Domestic Animal Infectious Diseases Control Law, Article 43	①Three Vietnamese illegally carried a total of 5.25 kg of sausage and meat products derived from pork from Vietnam into Kansai International Airport in Japan, which is prohibited by the law, on 17 June 2019. ②The Vietnamese illegally carried 17.6 kg of dog meat from Vietnam into Kansai International Airport in Japan on 6 August 2019. ③The Vietnamese illegally carried 2.0 kg of beaf from Vietnam into Kansai International Airport in Japan on 15 August 2019.		Osaka Prefectural Policy Headquarters arrested the Vietnamese on 15 October 2019.
import	Livestock derived products (hand luggage)	Thailand	Act on Domestic Animal Infectious Diseases Control, Article 36(1),63(2) Enforcement Regulations of the Domestic Animal Infectious Diseases Control Law, Article 43	A Thai illegally carried 10.45 kg of sausage from Thai into Narita International Airport in Japan, which is prohibited by the law, on 25 November 2019.		Chiba Prefectural Policy Headquarters arrested the Thai on 21January 2020.
