Revisions of the Ordinance for Enforcement of the Plant Protection Act and relevant requirements

The revisions of the Ordinance for Enforcement of the Plant Protection Act and relevant requirements were notified by G/SPS/N/JPN/905 on 17 December 2021, and these have been published in the Japanese Official Gazette on 22 March 2022.

These revisions and requirements have entered into force on 23 March 2022.
