## NOTIFICATION

### *Corrigendum*

The following communication, received on 5 February 2016, is being circulated at the request of the Delegation of Japan.

Proposed revision of the Ordinance for Enforcement of the Plant Protection Act and relevant notifications; Correction

This notice is issued to correct "6. Non-Quarantine Pest List" which is hyperlinked in Item 6 of the notification G/SPS/N/JPN/438 dated 16 December 2015. The corrections are as follows:

- 1) A note "excluding those are attached to plants for planting" is inserted after each following 28 existing non-quarantine pests in "a. Arthropods" of "1. Injurious Animals":

*Aceria tulipae, Aphis craccivora, Aphis fabae, Aphis gossypii, Aulacorthum circumflexum, Aulacorthum solani, Brachycaudus helichrysi, Brevipalpus californicus, Cavariella aegopodii, Ferrisia virgate, Frankliniella fusca, Frankliniella intonsa, Frankliniella occidentalis, Frankliniella tenuicornis, Hypera postica, Hyperomyzus lactucae, Lipaphis erysimi, Macrosiphum euphorbiae, Myzus ascalonicus, Myzus ornatus, Myzus persicae, Parabemisia myricae, Pseudococcus longispinus, Rhopalosiphum maidis, Rhopalosiphum padi, Scirtothrips dorsalis, Thrips palmi, Trialeurodes vaporariorum*

- 2) A note "excluding those are attached to plants for planting" is inserted after each following 12 newly added non-quarantine pests in "c. Viruses" of "2. Injurious Plants and Microorganisms":

*Freesia mosaic virus, Hippeastrum mosaic virus, Iris mild mosaic virus, Lily symptomless virus, Lily virus X, Narcissus degeneration virus, Narcissus late season yellows virus, Narcissus latent virus, Narcissus mosaic virus, Narcissus yellow stripe virus, Plantago asiatica mosaic virus, Tulip mosaic virus*
